## IMPORTANT POST-SENTENCE INFORMATION FOLLOWING GAGNON II HEARING

- 1. After you are sentenced, you have the right to file a motion to modify sentence and/or an appeal to the Superior Court of Pennsylvania.
- 2. If you wish to file a motion to modify sentence, it must be filed with the Clerk of Courts-Criminal for Lehigh County no later than 10 days after the imposition of sentence.
- 3. If you wish to file only a direct appeal to the Superior Court, a Notice of Appeal must be filed with the Clerk of Courts-Criminal for Lehigh County within 30 days of imposition of sentence. This is a right of appeal which you may exercise without filing a post-sentence motion. The filing of a motion to modify sentence will not toll the 30-day appeal period.
- 4. Regardless of whether you file a motion to modify sentence, all issues properly raised at sentencing are preserved for appeal.

5. You have the right to assistance of counsel in the preparation of a motion to modify sentence or an appeal. If you are truly indigent, you have the right to proceed without payment of costs and with counsel appointed to represent you without charge. If you are now represented by the Public Defender's Office and you continue to qualify for their services, then that office would continue to represent you without cost. 6. Do you understand that if you are represented by defense counsel, if you do not file a post-sentence motion or an appeal, that lawyer's representation of you will terminate in 30 days? 7. Do you agree to appear for your court hearing by advanced communication technology such us Zoom, WebEx, Polycom, etc. (on a computer) instead of physically being in the courtroom in front of the judge? You waive this right freely, voluntarily and intelligently.

5.	You shall abstain from the unlawful possession, use, or sale of illegal drugs, mood altering or synthetic substances deemed to be illegal under the laws of the Commonwealth of Pennsylvania. Prescription medication may only be taken if and as prescribed.

7.	You shall obtain and maintain employment. Your supervising officer must be notified within 72 hours of any change or loss of employment.
