The Court requires parents and other parties in custody cases and divorce cases that include a custody count to complete COPE.

- Please remember that children are not to be brought to the class.
- **Class is three hours.**
- Please arrive 15 minutes prior to the start of class. Doors close promptly at the beginning of training. Anyone arriving after 9:00am on Saturdays or after 5:30pm on Wednesdays will need to reschedule.
- A message will be available at 610-427-0619 in case of cancellation due to inclement weather.
- Attending class via Zoom is an option **ONLY** for those who live over 90 miles away from the courthouse. Prior permission is required.
