WAIVER OF SECTIONS 6335 AND 6341(b) OF THE JUVENILE ACT

I have been informed of and understand my rights under the Juvenile Act Sections 6335 and 6341(b). Section 6335 provides that after a petition has been filed alleging me delinquent and I am in detention, a hearing must take place no later than ten days after the filing of the petition. Section 6341(b) provides that if I am found delinquent at my adjudication hearing and I remain detained, a hearing shall take place no later than twenty dates after such finding.

Nevertheless, I hereby give up these rights during the period of the continuance requested, with the understanding that the period of this continuance will not count in computing Section 6335 or Section 6341(b) time.
