## NOTES REGARDING MOTIONS PRACTICE

- ▶ Draft copies of minors' compromise petitions must be submitted to Orphans' Court Counsel/Law Clerk for review PRIOR to presentation/filing, pursuant to Leh.R.C.P. 2039. After completion of the review, presentation may be scheduled or directions for submission of the original petition will be issued by subsequent Court Order.
- ▶ Copies of motions for leave to withdraw as counsel to a personal representative, with a proposed order, must be submitted to Orphans' Court Counsel for review at least 3 weeks prior to the calendared OC Motions date on which counsel intends to present it.
- ▶ Uncontested walk-in OC Motions, other than minors' compromises and motions to withdraw as estate counsel, may be presented during Judge Johnson's weekly civil walk-in motions dates if there is no scheduled OC Motions date within 3 weeks of the scheduled Civil Motions date.
- ▶ Petitions for preliminary orders awarding citations and all adoption and parental termination petitions are to be filed directly with the Clerk of the Orphans' Court Division and not presented in motions court.
